

## **Northern Premier League EDI Policy and Complaints Procedure**

### **Updated April 2025**

The aim of this policy is to ensure that all members of the community are treated fairly and with respect and that The Northern Premier League is equally accessible to them all.

The Northern Premier League is responsible for setting standards and values to apply throughout the League at every level. Football belongs to and should be enjoyed by everyone, equally.

Our commitment is to confront and eliminate discrimination whether by reason of gender, sexual orientation, marital status, race, nationality, ethnic origin, colour, religion or belief, ability or disability and to encourage equal opportunities.

This policy is fully supported by the Board of Directors of The Northern Premier League and is responsible for the implementation of this policy.

Equality at The Northern Premier League means that in all our activities we will not discriminate, or in any way treat anyone less favourably, on grounds of gender, sexual orientation, marital status, race, nationality, ethnic origin, colour, religion or belief, ability or disability.

It means that we will ensure that we treat people fairly and with respect and that we will provide access and opportunities for all members of the community to take part in, and enjoy, our activities. And it means that we will not sanction any action, or lack of action, which might disadvantage a member compared to other people for any reason related to the list above.

The Northern Premier League will not tolerate harassment, bullying, abuse or victimisation of an individual (which for the purposes of this policy and the actions and sanction applicable is regarded as discrimination). This includes sexual or racially based harassment or other discriminatory behaviour, whether physical or verbal.

The Northern Premier League will work to ensure that such behaviour is met with appropriate action in whatever context it occurs.

We are committed to the development of a programme of ongoing training and awareness raising events and activities in order to promote the eradication of discrimination within The Northern Premier League and in the wider context, within football as a whole.

We are also committed to circulating this policy to all our members and working with them to ensure that this is a shared policy that all members collectively work towards.

The Northern Premier League is committed to a policy of equal treatment of all members and requires all members to abide and adhere to these policies and the requirements of the Equality Act 2010

The Northern Premier League commits itself to the immediate investigation of any claims of discrimination on the above grounds and where such is found to be the case, a requirement that the practice stop and sanctions be imposed, as appropriate. We will also work with County FAs to achieve the same outcomes.

### **League Complaints Procedure**
